Highlights from Second Quarter

Aces

Unbelievably, the VGA has had three holes-in-one in our second quarter, including two one week apart. All three members had their first aces of their golf careers.

Jandy Johnson started the quarter by **acing hole number eight at Bear Creek** on April first. She used an **eight iron on the 125 yard hole**. On a blind shot, she hit a draw and did not see the ball drop into the hole.

On June 3 Paul Mickela used a six iron to ace the 157 yard hole number seven at Westbrook Village Lakes Course. He hit the shot to the right of the hole and drew it onto to the green and watched the ball roll into the hole.

One week later on June 10, **Ken Slagle aced the 145 yard second hole at Lone Tree**. He used a six iron, but did not realize that he had a hole-in-one until he found the ball in the hole.

Since the **VGA** instituted the hole-in-one pot on November 1, 2017, its members have had eight holes-in-one through June of 2020. We have played approximately 21,000 par three holes in that period of time. That means that we have scored a hole-

in-one about once for every 2,625 par three holes played. To put that in perspective, according to the **National Hole-in-One Registry**, the odds that an **average player will score a hole-in-one are 12,000 to 1** and the odds for a **high handicapper are 5,000 to 1**. Unbelievably, **the odds for a pro are 3,000 to 1**, which is less often than the VGA's record for the above time period.

For your information, each year \$5.00 of every member's dues is put aside in the hole-in-one pot. Over the last few years we have at least 120 members join each year resulting in over \$600 in hole-in-one money. On October 31, the end of our schedule year, the pot is divided by the number of holes-in-one made by members in VGA events.

Also for VGA events, the VGA pays each member who scores a **hole-in-one \$100** out of the treasury and will pay up to **\$100** toward the ensuing bar tab. The following is a list of the other five holes-in-one mentioned above;

Fred Baldwin – Bear Creek hole number 2 – 137 yards – six iron – November 1, 2017 Neal Fisel – Stonecreek hole number 12 – 175 yards – five wood – April 11, 2018 Dan Delgado – ASU Karsten number 16 – 178 yards – five iron – September 1, 2018 Rusty Silverman – San Ignacio number 7 – 112 yards – gap wedge – May 26, 2019 Jim Cox – Lookout Mountain hole number 11 – 152 yards -seven iron- June 26, 2019

And then again there is **Fred Baldwin**. He has scored **five aces in VGA play**, the first on March 26, 2011 and the fifth on November 1, 2017. During that time span he played about 650 rounds and approximately 2,600 par three holes. That works out to be **one hole-in-one for every 520 holes played!** His list of holes-in-one is as follows:

Letters to Arnie

Dear Arnie.

During a recent round in tournament play, a member of my foursome hit a bad drive. He then teed up another ball and hit again. As he walked off of the tee, he said that he hit a provisional ball. Should he have announced he was hitting a provisional before he hit the second ball? **Peter Pro**

Dear Peter.

As per USGA rule 18.3 Provisional Ball, he should have announced beforehand that he was hitting a provisional ball. The rule is as follows;

b. Announcing Play of Provisional Ball

Before the stroke is made, you must announce that you are going to play a *provisional* ball.

It is not enough for you only to say that you are playing another ball or are playing again.

You must use the word "provisional" or otherwise clearly indicate that you are playing the ball provisionally under Rule 18.3.

If you did not announce this (even if you intended to play a *provisional ball*) and played a ball from where the previous stroke was made, that ball is your ball *in play* under penalty of *stroke and distance*.

As a consequence, the above golfer would be required to play the second ball which would be lying three and he would be hitting four.

Dear Arnie,

Recently, while putting, my ball hit another player's club resting on the green. Should I have taken a penalty stroke? **Puttin' Pete**

Dear Pete,

According to a recent article, "Putting Green Master Class, in <u>AZ Golf</u> written by Ed Gowan you should have replaced your ball. As he wrote;

"When a ball is in motion from a stroke on the putting green and hits any person, animal, another ball in motion or movable obstruction on the putting green, it must be replaced and replayed."

This means, in your case, if you did not replace the ball, you should been assessed a two-stroke penalty. Also, once the ball is played again, you can no longer replace the ball.

Gowan goes on to say if your ball hits another ball (in play) at rest, then play the ball as it lies. Also, the struck ball must be replaced as close to the point of contact as possible.

However, if the ball was hit from off of the green, the ball remains in play and is to be played from where it lies.
